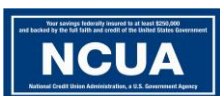

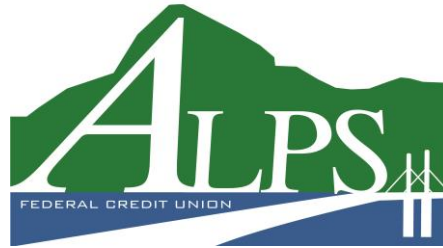

Inactivity/Minimum Balance	\$5.00/month if account is inactive for more than 90 calendar days and has a balance below \$100.00. When account reaches \$0.00 balance it will be closed.

Miscellaneous Fees - Continued	
Excessive Withdrawal	<p>\$3.00/withdrawal. For all share account types (except checking accounts): During any calendar month, each share account type may not have more than six withdrawals from or transfers to another Credit Union account of yours or to a third party by means of a pre-authorized or automatic transfer or telephonic order or instruction, or by check, draft, debit card, if applicable, or similar order to a third party. If you exceed these limitations, the account will be subject to closure.</p>
Check Cashing Fee	<p>\$7.50/check for non-members Members who have an ALPS checking, savings and/or money market account:</p> <ul style="list-style-type: none"> • If you have an ALPS checking, savings and/or money market account with enough money in your accounts to cover the amount of the check being cashed, the check may be cashed with no fee. Under our funds availability policy, we may place a hold on funds in your accounts for the same amount as the check being cashed. • If you have an ALPS checking, savings and/or money market account and you do not have enough money in your accounts to cover the amount of the check being cashed, we may still cash the check. If the check was drawn on an ALPS account, there will be no fee. Otherwise, a check cashing fee may apply. <p>TIP: You may avoid check cashing fees by depositing your checks rather than cashing them.</p>
